Cost Saving Measures

Design Stage

1 Is it a safe building?

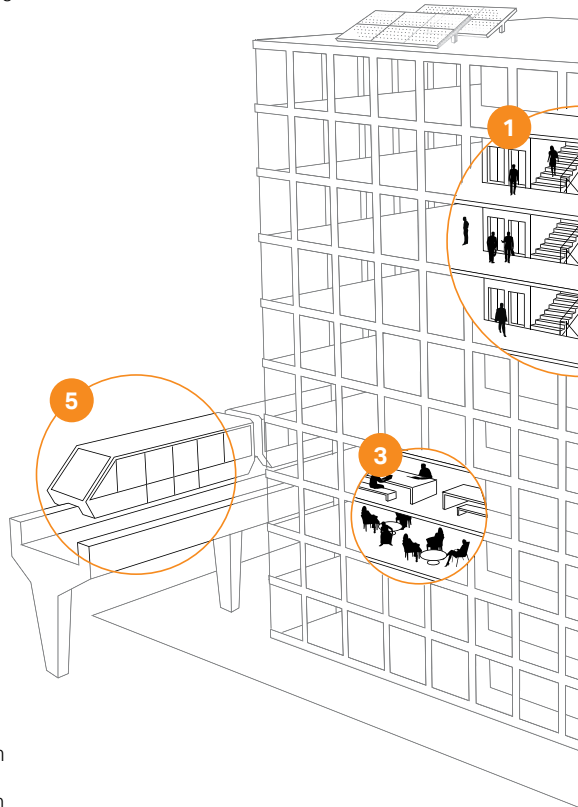
AECOM will work as an integral part of the design team to establish that the end use of the building is fully considered during the design phase. We will challenge the design team to understand that the implications of all design decisions are fully thought through during the design process. We will make certain that design risk assessments are completed at all stages of the project and potential risks are mitigated by the design team. In conjunction with this we will also undertake H&S audits and compliance reviews to maintain safe work systems throughout the construction phase.

2 Is it a safe building to construct?

AECOM will endorse that the buildability of the structure is at the forefront of the design teams mind from the outset. We will challenge the design team to ensure that they are fully cognisant of how their design can be constructed. It is imperative that all design assumptions are communicated to the PSCS/ Contractor at the start of the construction period. We will strive to make sure all design information is communicated so as to mitigate all potential risks.

3 Is the information about the building comprehensive?

AECOM will set out to establish that the design team gather all information available on the existing site/building. This information will then be communicated to those working on the site/building by way of the preliminary H&S plan to arrange that the contractors are fully aware of the potential risks posed to the site/structure.





Construction Stage

4 Have the contractors been provided with a safe environment to work?

AECOM as H&S consultants will provide appropriate measures so that the contractors and the PSCS comply with all relevant H&S legislation, endeavouring to provide a safe working environment for personnel working on the site. AECOM will carry out regular site audits to check this compliance is maintained.

5 Is the building safe to travel to/from and around?

As H&S consultants we will ask the challenging questions to ascertain whether the potential risks presented when travelling to/from and around the site/building are mitigated. We will make sure that all design decisions are made with the end user in mind.

Operation Stage

6 Is it a safe building to operate and maintain?

AECOM will make certain the Safety File produced for the project is comprehensive and provides all the information required by a client to safely use and maintain the building.
